Proposed Action Title: University of Southern California - Inexpensive Metal Free Organic Redox Flow Battery

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Los Angeles, CA

Proposed Action Description:

Funding will support the continued development of a water-based, metal free, grid-scale flow battery that stores chemical energy in external tanks instead of battery containers. If successful, the proposed battery will ultimately reduce cost, increase durability, and promote greater renewable energy deployment.

Project tasks involve small-scale and pilot-scale research and development activities in laboratory facilities at the University of Southern California and ITN Energy Systems. All project work will take place in Los Angeles, CA, and will comply with applicable federal, state, and local requirements. No modifications will be made to existing facilities to accommodate the proposed work.

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Los Angeles, CA

Proposed Action Description:

The University of Southern California will perform research to develop an aqueous flow battery that uses organic redox couples that meets the cost, durability, and sustainability requirements for grid-scale electrical energy storage.

All project activities will take place at the University of Southern California's laboratory facility in Los Angeles, CA.
