<u>Proposed Action Title</u>: Texas A&M AgriLife Research - Developing Ground Penetrating Radar (GPR) for Enhanced Root and Soil Organic Carbon Imaging: Optimizing Bioenergy Crop Adaptation and Agro-ecosystem Services

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop ground penetrating radar antenna arrays for 3D root and soil organic carbon imaging and quantification. Specifically, the project team will: (1) define optimal ground penetrating radar (GPR)-antenna array; (2) develop and optimize agriculture field-based, small scale GPR; (3) test the optimized GPR; and (4) develop 3- and 4-dimensional data analysis methodologies for using GPR for crop root and soil imaging and quantification. If successful, visualization of root traits with one millimeter resolution in soils could enable breeders to select climate-resilient bioenergy crops that provide higher yields, require fewer inputs, improve soil health, and promote carbon sequestration.

Project activities will be conducted at existing facilities that are designed for the applicable activities, and will be conducted in accordance with applicable Federal, State, and local safety and environmental requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
