Proposed Action Title: Cornell University (Cornell) - PolarJFET - A Novel Vertical GaN Power Transistor Concept

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Ithaca, NY; Richardson, TX; East Hartford, CT; and Somerset, NJ

Proposed Action Description:

This award was recently novated to Cornell resulting in a new NEPA review. Consistent with ARPA-E's prior determination for this project, ARPA-E has determined that project work will remain laboratory-based, small-scale, research and development activities that are categorically excluded from further review. Specifically, funding will support ongoing research and development activities to develop miniaturized, high-efficiency, gallium-nitride (GaN) power switches that require substantially lower energy than current silicon based technologies. If successful, Cornell's small, high-performance, low-cost GaN power transistors would significantly improve the efficiency of a variety of power electronics, including motor drives.

Research and development activities will be conducted in Cornell's laboratory facility located in Ithaca, NY; Triquint Semiconductor's laboratory facility located in Richardson, TX; United Technologies Research Center's laboratory facility located in East Hartford, CT; and IQE's laboratory facility located in Somerset, NJ. All work will be performed in accordance with applicable Federal, State, and local safety, environmental, land use, and zoning requirements.

Proposed Action Description:

The University of Notre Dame, in conjunction with Triquint Semiconductor, IQE, and United Technologies Research Center, proposes to conduct laboratory based, small-scale, research and development activities for miniaturized, high-efficiency, gallium-nitride (GaN) power switches. The proposed activities aim to develop cost-effective GaN devices that require substantially lower energy than current silicon based technologies.
