Proposed Action Title: Massachusetts Institute of Technology (MIT) - Mobility Electronic Market for Optimized Travel (MEMOT)

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Cambridge, MA and Amherst, MA

Proposed Action Description:

Funding will support development and testing of a mobility market and information software to incentivize travelers to pursue specific routes, departure times, modes of travel, and vehicle types in order to reduce energy use. The software's system model will use real-world data obtained from existing resources to simulate the transportation network of the greater Boston area and dynamically measure energy use as changes to the transportation network occur. In addition, the system model will be linked with a control architecture that presents users with personalized options via a smartphone application or a vehicle's on-board computer system, and will include a reward points system to incentivize users to adopt energy efficient travel options. If successful, development of a novel system model and architecture that dynamically simulates urban transportation networks would demonstrate the level of energy efficiency gains that can be accomplished through network optimization approaches.

Research and development activities will be conducted in MIT's laboratory facility located in Cambridge, MA and the University of Massachusetts, Amherst's laboratory facility located in Amherst, MA. Any behavioral research/testing of a proof of concept system model and architecture performed by MIT will be subject first to the review and approval of an Institutional Review Board (IRB), and will comply with the requirements of: (1) DOE Order No. 443.1B (Protection of Human Research Subjects); (2) 10 C.F.R. Part 745; and (3) 45 C.F.R. Part 46.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
