Proposed Action Title: Hassayampa Switching Station - Geologic Investigation

Program or Field Office: Western Area Power Administration/Desert Southwest Region

Location(s) (City/County/State): Hassayampa Switching Station, Buckeye, Arizona

Proposed Action Description:

Western Area Power Administration proposed to conduct geologic investigations at approximately 6 sites at the Hassayampa Switching Station. located near Buckeye, Arizona. Geologic information is required to complete the design and future construction. Geologic investigations would include: geologic mapping; subsurface investigation; earth resistivity testing; laboratory testing; and reporting.

Five of the bore holes will be with the existing property boundary and one bore hole will be in the existing transmission line right of way. The investigation consists of drilling bore holes, approximately 4 inches in diameter and 35 feet in depth, collecting soil or rock samples, and would backfill the holes with the removed materials. Workers will drive rubber-tired vehicles (truck-mounted auger or drill rig), a backhoe with an auger attachment, and a crew truck on existing access roads to reach bore hole locations. Road improvements are not required for this scope of work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.

Special Considerations:

<u>Cultural Considerations</u>: On rare occasions, cultural or paleontological sites may be discovered during excavation or other earth-moving activities. Reporting: If archaeological material, paleontological material, or human remains are discovered, cease work in the area immediately and notify the Regional Preservation Officer at 602-605-2842. Stop all activities within a 100-foot-radius of the discovery, and do not proceed with work within that radius until approval by the Regional Preservation Officer. Care of Evidence: Protect the area. Do not remove, handle, alter, or damage artifacts or fossils uncovered during construction.

<u>Biological Considerations</u>: There is no effect to any species listed or critical habitat pursuant to the Endangered Species Act. Pursuant to the Migratory Bird Treaty Act, if there are any active nests (with young or eggs in it), contact Western's Biologist before approaching the nest for instruction on how to proceed.
