Proposed Action Title: Princeton University - Fast Electrochemical Acoustic Signal Interrogation for Battery Lifetime Extrapolation (FEASIBLE)

Program or Field Office: Advanced Research Projects Agency - Energy

## Proposed Action Description:

Funding will support Princeton's attempt to build a non-invasive (acoustic) method for monitoring the state-of-charge and state-of-health of a wide variety of closed cell batteries. If successful, Princeton will deliver a measurement technique and analysis algorithm that can be readily embedded into battery management and quality control systems. Project tasks will involve measuring acoustic responses to batteries that are driven to failure; developing a functioning algorithm that can be used to indicate the state-of-charge and state-of-health of batteries; developing software; and creating a small demo system at Princeton's laboratory facility in Princeton, NJ. Project work will be performed by trained personnel and in compliance with applicable federal, state, and local requirements. No modifications will be made to existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
