Proposed Action Title: Gas Technology Institute - Methane Soft Oxidation

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Des Plaines, IL

## Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a sulfur-based methane oxidation process, known as soft oxidation, to convert methane into liquid hydrocarbons, recover valuable liquids and hydrogen gas, and recycle the remaining products. Specifically, the project team will: (1) conduct process modeling and techno-economic analysis; (2) conduct soft oxidation reactor testing and develop a first stage reactor; (3) conduct reactor testing; and (4) conduct recycle system testing. If successful, the soft oxidation process could economically convert biogenic methane emissions and allow the potential for economic operation at small-scale and the utilization of distributed methane resources.

Project tasks will be conducted on a small-scale basis in dedicated laboratory and testing facilities at Gas Technology Institute (Des Plaines, IL). Project tasks will be conducted in accordance with with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
