Proposed Action Title: University of Nebraska, Lincoln - Voltage and Frequency Power Converter Based on Electromagnetic Induction

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Lincoln, NE

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop an electromagnetic (EM) power converter for variable-frequency and variable-voltage energy conversion. Specifically, the project team will: (1) develop and test three prototypes of a magnetic flux valve, design and validate single power converter module, and complete printed circuit board design; (2) develop, test, and validate performance metrics of the driver circuit and first prototype of 50-W single power converter module; (3) develop and test driver circuits for magnetic flux valves and additional 50-W single power converter module, validate performance metrics of 150-W single-phase EM power converter, and design 1-kW single power converter module; (4) develop 150-W single power converter module and conduct preliminary scalability test. If successful, the converter will establish a basis for new innovations in various industrial electrical-electrical energy conversion, renewable power generation, and smart grid applications.

Project activities will be conducted at existing facilities that are designed for the applicable activities at the University of Nebraska, Lincoln (Lincoln, NE). Project tasks will be conducted in accordance with with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.
