<u>Proposed Action Title</u>: Oak Ridge National Laboratory - New High Temperature, Corrosion-Resistant Cast Alloy For Operation in Industrial Gaseous Environments

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Milwaukee, WI; East Chicago, IN; Coatesville, PA; Scottsdale, PA; Waukesha, WI; Oak Ridge, TN

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop new cast alumina-forming alloys (AFAs), along with associated casting and welding processes for component fabrication. Specifically, the project team will: (1) design the alloy and evaluate microstructural durability; (2) develop casting and welding processes required to fabricate cast alumina forming alloys; (3) evaluate physical and mechanical properties, environmental resistance, and the effect of the heat-treatment furnace environment on alloys; and (4) design, fabricate, install, and evaluate the performance of a furnace roll fabricated from a cast alumina-forming austenitic stainless steel. If successful, these innovations would allow various industrial and chemical processing systems and gas turbines to operate at higher temperatures, improve efficiencies, and reduce downtimes.

Project activities will be conducted at existing facilities that are designed for the applicable activities at Oak Ridge National Laboratory (Oak Ridge, TN), University of Wisconsin-Milwaukee (Milwaukee, WI), ArcelorMittal USA (East Chicago, IN and Coatesville, PA), MetalTek International (Waukesha, WI), and Duraloy Technologies (Scottsdale, PA). Project tasks will be conducted in accordance with with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically-excluded from further NEPA review.
