<u>Proposed Action Title</u>: University of Maryland -- A Case Study on the Impact of Additive Manufacturing for Heat/Mass Transfer Equipment Used for Power Production

Program or Field Office: Advanced Research Projects Agency-Energy

Proposed Action Description:

University of Maryland, in conjunction with Baltimore Aircoil Company, Boeing Company, Michigan Technological University, Honeywell International Inc. - Aerospace Division, and Solid Concepts Inc., proposes to develop next-generation air-cooled heat exchangers that can operate in dry or hybrid mode and substantially reduce (or eventually eliminate) the cooling water consumption in condenser cooling of stream electric generation plants. The proposed project will involve: (1) surveying/assessing the state-of-the art technologies for air-side heat transfer augmentation and the applicable additive manufacturing and/or other advanced manufacturing technologies; (2) running computer simulations to analyze performance of at least two different heat exchanger configurations and corresponding manufacturing techniques; and (3) assembling, testing, and analyzing bench-scale prototype units.

All project tasks will be performed in dedicated industrial and university laboratory and computing facilities at University of Maryland (College Park, MD), Baltimore Aircoil (Jessup, MD), Boeing (Huntington Beach, CA), Michigan Technological University (Houghton, MI), Honeywell (Torrance, CA), and Solid Concepts (Austin, TX).

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
