Proposed Action Description:

Funding will support the project team's information gathering and analysis efforts to develop an open-source software tool deployable locally and on the internet that aggregates and visualizes a wide variety of publicly available data on energy and material imports, exports, and flows in the US economy. If successful, this visualization will allow users, including researchers, funding agencies, policy makers, and the public, to examine the flows of energy and materials by industry, region, and economic sector with the specificity and comprehensiveness necessary to identify areas ripe for transformative energy technology development.

The proposed project activities under this award are limited exclusively to intellectual, academic, or analytical activities. The project team will not conduct physical experiments, prototype fabrication, demonstration projects, or similar activities under this award.
