Proposed Action Title: Pinnacle Peak Substation - Erosion Control

Program or Field Office: Western Area Power Administration - Desert Southwest Region

Location(s) (City/County/State): North Scottsdale, Maricopa County, Arizona

## Proposed Action Description:

The Western Area Power Administration (WAPA) is proposing to perform erosion control maintenance on the existing access roads and upland drainage areas surrounding the Pinnacle Peak Substation (PPK). The existing access roads and drainage areas have experienced severe erosion from rain/wind events and need to be repaired so WAPA staff can continue to safety operate and maintain the PPK substation.

Proposed work includes using a dozer to grade the existing access roads situated immediately west, north and east of the substation and returning the area to its former condition. There would be no expansion of existing access, only the existing access road footprint would be maintained. Additionally, the existing upland drainages would be re-shaped and contoured back to its original condition.

Work is anticipated to begin in October 2017 and should take approximately 4-6 weeks to complete.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

## \*\*\*Special Conditions\*\*\*

- 1) Within one (1) week before the project commences, WAPA's Biologist will perform a preconstruction biological survey and flag any avoidance areas. The construction contractor shall avoid all flagged areas.
- 2) Sonoran desert tortoises are unlikely to be present in the project area; however, if a tortoise is found in the project area, project activities shall cease and WAPA's Environmental Department (602-605-2599) shall be contacted immediately. If the tortoise does not leave the project area on its own, WAPA's Biologist or qualified environmental staff member will move the tortoise to another location.
- 3) If evidence of a cultural or paleontological site is discovered, cease work in the area and immediately notify WAPA/DSW's Environmental Department at 602-605-2842. Stop all activities within a 50-ft radius of the discovery and do not proceed with work within that radius until directed to do so by WAPA/DSW's Environmental Department.
