<u>Proposed Action Title</u>: Renewable Energy to Fuels Through Utilization of Energy-Dense Liquids (REFUEL) Program (FOA No. DE-FOA-0001562 & DE-FOA-0001563 (SBIR/STTR))

## Proposed Action Description:

The REFUEL Program seeks to fund the development of scalable technologies for converting electrical energy from renewable sources into energy-dense carbon-neutral liquid fuels and back into electricity or hydrogen on demand. The REFUEL Program is composed of 16 small-scale research and development projects that will be conducted by universities, non-profit entities, for-profit entities, and federal laboratories. If successful, REFUEL technologies will accelerate the shift to domestically produced transportation fuels, improving American economic and energy security and reducing energy emissions.

All of the 16 REFUEL projects (listed in Attachment A) are covered by this Determination and fit within the class of actions identified under the DOE Categorical Exclusions identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the projects. This assessment was based on a review of the proposed scope of work and the potential environmental impacts of each project. Project tasks for all 16 projects under the REFUEL Program will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and Local regulatory requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
