<u>Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021)</u>: B1.25 Real property transfers for cultural resources protection, habitat preservation, and wildlife management

Description of the Proposed Action: BPA is proposing to fund the Kalispel Tribe of Indians to purchase the Beaver Lake III property, a 40-acre parcel of land located 3 miles northwest of Sand Point in Bonner County, Idaho. The United States would hold a conservation easement, which BPA would manage, to permanently protect, mitigate, and enhance fish and wildlife and their habitat.

Funding the purchase of the property would serve as partial mitigation for the construction and operation of the Federal Columbia River Power System which includes dams on the main stem Columbia and Snake rivers. This land purchase would specifically satisfy some of BPA's commitments made in the Memorandum of Understanding between the Kalispel Tribe of Indians and the Bonneville Power Administration.

The property consists of forested wetland and mixed conifer habitat. The Kalispel Tribe of Indians would develop a management plan to guide the protection and enhancement of habitat and other resources on the property. The management plan would be reviewed by BPA for consistency with the conservation easement and the purpose of the acquisition. If BPA proposes to fund any additional activities on the property, further environmental review may be conducted.

<u>Findings</u>: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix A of 10 CFR 1021, Subpart D (see attached Environmental Checklist;
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.

Project Site Description

The 40-acre Beaver Lake III property lies west of Lake Pend Oreille within a vast wetland complex. It sits east of Beaver Lake and north of Eaton Lake and is surrounded to the west, north, and south by conservation property owned by the Kalispel Tribe of Indians (totaling 480 acres), which provides the current means of access via Camp Bay Road - the eastern adjacent parcel is a private subdivision lot. The subject property is a single parcel in a rural area zoned for 10-acre minimum sized lots and the area has been used primarily for timber production, although the subject site has not been harvested for more than 50 years. The northern and southern boundaries have existing perimeter fencing, which are the only structures present. The land is comprised of 24 acres of mixed conifer and deciduous forest, 13 acres of freshwater wetland, and 3 acres of riparian forested shrub habitat. The property hosts Canada geese, mallard duck, black-capped chickadee, yellow warbler, and white-tailed deer. There are no ESA-listed species on the parcel.
