- A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA) proposes to replace old floor tiles, broken sub floor pedestals, and stringers in the Communication, Computer, and Networking rooms in the lower level of the Loveland Area Power Marketing and Operations Center (PMOC) building, located in Larimer County, Colorado. The services of a Contractor are needed to replace approximately 5,000 square feet of tiles and other flooring structure that was previously installed in the late 1980's or early 1990's in the three rooms of the Loveland Area PMOC.
