Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021): B1.19 Microwave, meteorological

and radio towers

<u>Description of the Proposed Action</u>: BPA proposes to allow Sprint Corporation to upgrade their antennas and equipment at existing wireless sites on BPA towers. The work would consist of removing six antennas at each site and replacing those with three new, slightly larger antennas. Remote Radio Heads (RRHs) would be added to the antenna mounts and new coaxial cables would be installed, connecting the RRHs to existing equipment located on the ground, beneath, or adjacent to the tower base. To ensure safety, BPA workers and subcontractors would complete the wireless antenna and coaxial cable installation work. The project does not involve any ground excavation.

**Findings:** In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.
