Proposed Action Title: Foro Energy - High Power Laser Decommissioning Tool

## Proposed Action Description:

AMENDED NEPA DETERMINATION: (See attached original Determination, dated February 28, 2019)

This Amended Determination follows the approval of additional milestones and funds to support the project team's small-scale, research and development activities to conduct "in situ" tests of its High Power Laser Decommissioning Tool inside an abandoned well. Specifically, the project team will (1) install coiled tubing; (2) connect high-power laser tool; (3) test integrated system on surface, and (4) conduct in-situ test of system. If successful, the project team's HPLDT will enable a more cost effective and efficient (30-50% time savings) solution to plugging and abandoning wells by eliminating the need for mechanical milling.

Project activities will be conducted at existing facilities at Foro Energy (Littleton, CO; Houston, TX, Hitchcock, TX) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
