Proposed Action or Project Description:

SRNL will test microbial extraction (biomining) of rare earth elements (REEs) and metals from REE and metal containing materials in lab scale studies. This project is based on a strategic need for REEs and metals in US manufacturing in consumer, industrial, and military applications. This work is supported by an SRNL LDRD entitled "Critical Element Biomining".
