HRTL Lab 134 is a laboratory used the Hydrogen Isotopic Processing Section for hydrogen related research and development activities. The primary function of the Pump Test Cart will be the evaluation of vacuum pump compression ratios and performance of various vacuum pumps utilizing various gases. This revision includes additional gases that will be evaluated including helium, krypton, and deuterium and NEG vacuum pumps and SAES Getter alloy will also be evaluated.
