Project Title: Stormwater Basin 300 Culvert Repair

Program or Field Office: Savannah River Site

Proposed Action or Project Description:

Heavy rains from a 2020 hurricane caused granite slabs in the bottom of the culvert under manhole 303 to shift, causing water to back up. Pressure from the backed up water caused the top of the manhole to blow off of the culvert base. There was also extensive soil erosion around the base of the culvert. The scope of work for this activity is to remove the granite slabs from inside three culvert manholes, inspect the pipelines for any other blockages, repair and replace the manhole gasket and top, and to repair the eroded areas to restore it to its original function and design.
