Project Title: Connection of a Borazine Scrubber to a Residual Gas Analyzer

Proposed Action or Project Description:

A sample gas containing borazine in a collection volume will be connected to a valve system and directed either directly to a residual gas analyzer for analysis or directed through a borazine scrubber and then to a residual gas analyzer for analysis in 999-2W. The efficiency of the borazine scrubber will be studied as part of research seeking to further develop hydrogen fuel cell technologies.
