Proposed Action or Project Description:

Ductwork in 773-A, A-Wing basement is separating at a steam coil. Ductwork will be repaired and insulation will be replaced as needed per WO 1832178.

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or § 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
