Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

CX, EA, EIS APPENDIX AND NUMBER:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the New Hampshire Office of Strategic Initiatives to provide a loan to the NH Community Development Finance Authority to install a roof mounted 79.8 kW/AC (108.8 kW/DC) solar electric array on a commercial property in Gilmanton, NH. The solar array would supply electricity to the building. Any excess power would be purchased by the local electric company.

The proposed array would consist of 320 panels, the associated inverters, conduit, racks, ballasts, and associated electrical wiring. The project would require a door to be sealed off on the side of the building to allow for the placement of inverters on the building. No other structural modifications would be required. Propane tanks currently located on the side of the building would be relocated to the back side of the building. The existing connection lines to the propane tanks would be close enough to the building so the lines could remain above ground. Additionally, the existing overhead service lateral powerline would be upgraded.

The building is not listed or eligible to be listed on the National Register of Historic Places and is not in or near a historic district.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
