Proposed Action Title: Woods Hole Oceanographic Institution -- Selective Breeding Technologies for Scalable Offshore Seaweed Farming

Proposed Action Description:

SECOND AMENDED NEPA DETERMINATION: (See attached original Programmatic Determination and First Amended Determination, dated Jan. 19, 2018 & Jan. 10, 2020).

This Amended Determination follows the approval of additional funds and an expanded milestone to support the project team's small-scale, research and development activities to conduct an additional field trial of macroalgae varieties that the WHOI team developed during the course of the project. Specifically, the project team will grow the macroalgae in the field, and harvest and evaluate the performance of the macroalgae. Additionally, the funds will help the team acquire a cryopreservation system to freeze the organisms for long term storage. If successful, the additional field trial will enable the project team to assess whether the breeding strategy successfully improved the yield of macroalgae.

Project activities will be conducted at existing facilities at Woods Hole Oceanographic Institution (Woods Hole, MA); University of New Hampshire (Portsmouth & New Castle, NH); and University of Connecticut (Stamford & Branford, CT) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal. State, and local regulatory requirements

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
