Proposed Action Title: Poncha Switchyard Emergency Buried Cable Repair

Location: Chaffee County, Colorado

A. PROPOSED ACTION DESCRIPTION:

Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), conducted emergency repairs to an existing 25-kilovolt (kV) buried cable outside its Poncha (PON) Switchyard perimeter fence in Chaffee County, Colorado. The 25-kV buried cable that provides station service power to the PON Switchyard faulted and resulted in a power outage. The emergency repairs were completed between August 10-12, 2021. The location of the fault was approximately 165 feet east of the PON Switchyard perimeter fence. Emergency repairs involved digging a trench to access the fault location, splicing and replacing the damaged cable, backfilling the trench using the same excavated topsoil, and restoring power. Equipment used for this project included an excavator. Work was confined to WAPA's property boundary associated with the PON Switchyard. No access road maintenance or new road construction occurred.

B. STIPULATIONS PERTAINING TO PROPOSAL:

This Categorical Exclusion (CX) covers work that has already been completed. No further work is authorized under this CX. If additional work is required, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
