Proposed Action or Project Description:

The Thomas Jefferson National Accelerator Facility (TJNAF or Jefferson Lab (J-Lab)) used a tritium filled vessel in a fundamental physics experiment. TJNAF then packaged the vessel in a Bulk Tritium Shipping Packaging (BTSP) container and shipped it to SRTE. Since the BTSP container arrived at SRS in August 2018, two attempts have been made to unpack the container. Both unpacking attempts were unsuccessful due to the high level on contamination present. SRTE plans to connect the BTSP container to the unpacking station in 234-H, Room 291 to vent the Protective Cap and Containment Vessel. The unpacking station connects to atmosphere by 234-H Stack. After unpacking, the JLab cell will be unloaded and disposed.
