## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the National Rural Electric Association. (NREA) to create a Rural Area Distributed Wind Integration Network Development.

Work would include convening and surveying co-ops and stakeholder groups and other key partners, identifying case studies and common practices, and compiling and sharing a compendium of materials produced from the above tasks. DOE has completed one pervious NEPA determination (GFO-0008958-001; CX A9, A11; 3/20/2020). Since that determination NREA has made minor modifications to the Statement of Project Objectives. Those changes include increasing the number of case studies, creation of a more robust database than previously planned, and coordination with the Pacific Northwest National Laboratory on some aspects of the project.

All work would remain limited to information gathering and technical assistance.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

#### FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
