Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to the University of Colorado - Boulder (CU Boulder) in support of a research and development project that aims to develop a complete process for production of jet fuel from cellulosic biomass. The project would build on work completed previously by the National Renewable Energy Laboratory (NREL) and Virent Inc. and would be completed over three Budget Periods (BPs).

Project activities would include initial verification of previously completed work, catalyst identification and development, design and assembly of bench- and laboratory-scale equipment and reactors, biomass generation (100kg) and purification, operation of the reactors and processing equipment to produce 2-4 gallons of jet fuel, and ASTM testing of the jet fuel. Project partners that would complete work in support of this project include Virent Inc., Shell Global Solutions, and NREL.

Project activities would occur in purpose-built facilities, requiring only minor ventilation and electrical modifications. The project would involve the handling of hazardous materials including solvents and flammable gases at bench- and laboratory-scale quantities. All handling of hazardous materials would occur in-labs dedicated to proper hazardous materials handling and disposal practices. Hazardous materials would be managed in accordance with federal, state, and local environmental regulations. DOE does not anticipate any adverse impacts to the human environment as a result of this proposed project.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
