Project Title: Replacement of Uninterruptible Power Supply (UPS) Units

Program or Field Office: Savannah River Site

Proposed Action or Project Description:

Building 264-H utilizes a uninterruptible power supply (UPS) system to provide backup battery power during loss of normal power. The first is referred to as UPS-1 and the second unit is referred to as UPS-2. These units were manufactured by Powerware in 2002, which has been bought out by Eaton. The current UPS cabinets are aging, and components are beginning to fail. In addition, cabinets are larger (capacity and footprint) than needed. Current UPS is running approximately at 1/3 of capacity. This replacement will result in a reduction of maintenance needs for the UPS units. UPS 2 is currently Safety Significant but will be re-classified to Production-Support prior to final design approval, procurement and installation.
