Proposed Action or Project Description:

The activity involves a collaborative effort between SRNL, Buffalo State College (BSC), and Idaho National Laboratory (INL). Samples of synthesized crystals using flux growth technique from BSC will be received by SRNL. SRNL will perform structural characterization and send the synthesized crystals to INL for further analysis and characterization.
