Description:

Outdoor tests and experiments for the development, quality assurance, or reliability of materials and equipment (including, but not limited to, weapon system components) under controlled conditions. Covered actions include, but are not limited to, burn tests (such as tests of electric cable fire resistance or the combustion characteristics of fuels), impact tests (such as pneumatic ejector tests using earthen embankments or concrete slabs designated and routinely used for that purpose), or drop, puncture, water-immersion, or thermal tests. Covered actions would not involve source, special nuclear, or byproduct materials, except encapsulated sources manufactured to applicable standards that contain source, special nuclear, or byproduct materials may be used for nondestructive actions such as detector/sensor development and testing and first responder field training.

Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to Appalachian State University in support of a research and development project aimed at minimizing snow loss in solar photovoltaic (PV) systems. The objectives of this project are to (1) evaluate the snow removal effectiveness and material durability of passive (using hydrophobic tape at the frame-glass interface) and active (heating tape) methods at indoor and outdoor facilities and (2) demonstrate the combined passive-active technique at two sites. The project would take place over a single Budget Period.

Proposed project activities include design, development, and outdoor testing of pulse heating snow removal system for PV modules. Design and development activities would occur at Appalachian State University for outdoor experiments and Arizona State University for indoor experiments. Outdoor testing would occur at two snow regions: Appalachian State University, Boone, NC and Michigan Technological University, Houghton, MI.

Indoor activities would take place in existing facilities, requiring no modification, no new or modified permits. A commercially available environmental chamber would be used for indoor weather testing. Outdoor testing activities would involve installing approximately 4 new PV modules on existing mounting systems at two sites. No ground

disturbing activities would occur and no modification to existing electrical infrastructure would be required. The PV modules would be removed at the end of the project and evaluated at Appalachian State University.

DOE does not anticipate any impacts to resources of concern as a result of this proposed project.
