Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to Electric Power Research Institute (EPRI) in support of a research and development project that would result in a better understanding of inverter failures at large-scale solar photovoltaic (PV) plants. The project would take place over two budget periods (BPs).

During BP1, EPRI would prepare well-instrumented string inverters and perform field- and lab-based testing to determine failure causes. The instrumented inverters would be installed and commissioned at an operational PV plant owned by Duke Energy. Inverters would also undergo accelerated lifetime testing and monitoring and subsequently be sent to a laboratory for failure analysis. During BP2, EPRI would analyze testing data and provide results including predictive maintenance recommendations, inverter service lifetime estimates, and inverter replacement and retrofit best practices.

Lab-based testing would occur in existing, purpose-built facilities. Field-testing would occur at a PV plant owned by Duke Energy. The field-testing activities would not require any change to existing operations at the plant. Hazards include electrical shock and/or arc-flash from unintentional shorting of high power conductors. Corporate health and safety policies would be followed during all project activities including inverter instrumentation, field-testing , and lab-

based testing. No new or modified permits would be required to support this proposed project.
