AMENDED NEPA DETERMINATION: (See attached original Determination, dated September 10, 2019)

This Amended Determination follows the approval of additional funds and period of performance to support the project team's small-scale, research and development activities to perform additional testing required to properly evaluate the shielding composition of its concrete mixture to satisfy industry scrutiny. Specifically, the project team will determine the appropriate proportions of materials applicable for long-term irradiation experiments and combine the optimum mixture proportions to validate the mixture design in accordance with American Society for Testing and Materials ("ASTM") protocols and Nuclear Regulatory Commission ("NRC") requirements. If successful, The project team will validate a mixture design that satisfies industry, NRC, and ASTM scrutiny.

Project activities will be conducted at existing facilities at the University of Florida (Gainesville, FL) and RJ Lee Group (Monroeville, PA) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements
