Proposed Action Title: Thermopolis-Lovell 115-kV Transmission Line Access Road

Maintenance

Location: Big Horn, Hot Springs, and Washakie Counties, Wyoming

Project Number: 2020-067

Expiration Date: December 31, 2027

A. PROPOSED ACTION DESCRIPTION:

Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to conduct routine access road maintenance on existing roads used to access Structures 0/1-2/4, 3/2-3/6, 9/7-11/4, 11/7-17/1, 17/4-23/3, 28/5-30/4, 31/4-32/5, 34/2-41/3, 43/4-45/3, 45/8-53/2, 56/1-56/6, 57/6-61/6, 65/2-68/8, 70/4-71/7, and 72/8-81/8 on the Thermopolis-Lovell (TH-LV) 115-kV Transmission Line, in Big Horn, Hot Springs, and Washakie counties, Wyoming. The full scope of the access road maintenance may include: blading; grading; removal of rocks, vegetation, and other obstacles impeding safe travel; installation, repair, and replacement of water bars, rip-rap, and other erosion control measures; and cleanout, repair, and in-kind replacement of culverts and other drainage features. Structure clearing will also be completed within fifty feet of Structures 3/1-3/4, 16/8-17/4, and 23/5-24/4. Equipment used for this project may include motor graders, bulldozers, excavators, dump trucks, compactors, skid-steers and brush-hog attachments, work trucks, mulchers, chippers, chainsaws, and ATVs. Work will occur on private lands and public lands managed by the State of Wyoming and the Bureau of Land Management. This work will be confined to WAPA's existing access road prisms and right-of-way (ROW); no new roads will be constructed.

B. STIPULATIONS PERTAINING TO PROPOSAL:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2027.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Cultural resource avoidance areas are identified on maps to be provided to WAPA's maintenance crews and/or Contractor. No ground disturbance is allowed within cultural resource avoidance areas. All access within cultural resource avoidance areas must occur via existing access roads. If ground disturbance within cultural resource avoidance areas is necessary, an RMR Archeologist must be contacted at (970) 302-4753 or (970) 286-3523. No ground disturbance within cultural resource avoidance areas is authorized until written notification to proceed is provided by an RMR Archaeologist.

- 4) Only in-kind culvert replacement and crossing maintenance is authorized. If culverts or crossings must be enlarged, expanded, or placed in new locations, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 5) If rip-rap or other fill must be placed within waters of the United States (within wetland boundaries or below the ordinary high-water mark of surface waters), RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 6) Any injured or orphaned birds and all observed active nests must be immediately reported to RMR Environment at (970) 593-8803 or (970) 342-6462. Any dead birds must be reported to RMR Environment within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 7) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately, and an RMR Archaeologist must be contacted immediately at (970) 302-4753 or (970) 286-3523. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 8) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately, and an RMR Archaeologist must be notified immediately at (970) 302-4753 or (970) 286-3523 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 9) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 10) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
