Proposed Action Description:

AMENDED NEPA DETERMINATION: (See attached original Determination, dated December 17, 2018)

This Amended Determination follows the approval of additional funds to support the project team's small-scale, research and development activities to fabricate an electrochemically-driven CO₂ separator (EDCS) to remove CO₂ from ambient air. The original goal of the project was co-development of a hydroxide exchange membrane fuel cell (HEMFC) stack and the EDCS unit; the project team is focusing the remainder of their research only on the EDCS unit. Specifically, the project team will develop a planar EDCS module for proof of performance to remove CO₂ from ambient air and manufacturability of the module. If successful, the EDCS will be used for direct air capture of CO₂, and preliminary analyses have suggested that the EDCS would be cost competitive and provide superior performance to the existing CO₂ removal technology.

Project activities will be conducted at existing facilities at University of Delaware, (Newark, DE) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

Proposed Action Title: University of Delaware -- Advanced Alkaline Membrane H₂/Air Fuel Cell System with Novel Technique for Air CO₂ Removal

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop the first H₂/air hydroxide exchange membrane fuel cell (HEMFC) system equipped with a compact, low-cost electrochemical pump (ECP) for CO₂ removal from the ambient air feed. Specifically, the project team will (1) develop an electrochemical carbon dioxide pump that can remove CO₂ from ambient air; (2) develop a HEMFC short stack fuel cell with performance and durability equivalent to current proton exchange membrane fuel cells (PEMFC); and (3) integrate the carbon dioxide pump and fuel cell, optimize performance using various components, and conduct laboratory test to validate target metrics. If successful, this project will demonstrate a 1-kW HEMFC system including a low-cost and low-volume CO₂ removal module that can deliver PEMFC-equivalent performance and record durability while operating on ambient air.

Project activities will be conducted at an existing facility at the University of Delaware (Newark, DE) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.
