Proposed Action Title: Improved Catalyst Design for Greenhouse Gas Reduction via Bulk Chemicals - Copernic Catalysts

Program or Field Office: Advanced Research Projects Agency - Energy

## **Proposed Action Description:**

Funding will support the project team's small-scale research and development activities to design novel chemical catalysts to reduce the energy use and carbon footprint of bulk chemical reactions. Specifically, the project team will (1) identify a catalyst material (2) develop the material into a commercially scalable catalyst product, and (3) develop high-level process design parameters for a pilot plant based on this catalyst product. If successful, this effort will create a faster trajectory for developing more energy efficient and reduced carbon processes for the bulk chemicals industry to develop more cost competitive zero-carbon chemicals and fuels.

Project activities will be conducted at existing facilities at Copernic Catalysts, Inc., Schrodinger, Alva, and Guido Radaelli (Cambridge, MA; New York, NY; Mountain View, CA; and Pleasant View, CA, respectively) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
