Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to kWh Analytics, Inc. to develop statistical computer models built on a database to predict solar energy output and generate a risk score superior to the currently used Photovoltaic Watts.

Activities associated with the proposed project would include collection of raw data, data quality verification, and the building of predictive statistical models. The proposed project would use no physical materials beyond basic office supplies and software.

Based on review of the project information and the above analysis, DOE has determined the proposed project would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined that this project is consistent with actions outlined in DOE categorical exclusions A9 "Information gathering, analysis, and dissemination" and A11 "Technical advice and assistance to organizations" and is therefore categorically excluded from further NEPA review.
