Rationale for determination:

The Department of Energy is proposing to provide funding to the American Council for an Energy-Efficient Economy (ACEEE), located in Washington D.C. for a variety of technical assistance activities with states and undertake new research and analysis on economic development relating to energy efficiency.

The proposed project would allow ACEEE to provide technical assistance to states where it has already completed an efficiency potential study, with a State Energy Efficiency Policy Database and State Energy Efficiency Scorecard. ACEEE would also target several new states that are ramping up energy efficiency activities, with technical assistance that would include energy efficiency potential assessments, policy analyses, and educational toolkits. Finally, the project would undertake new research and analysis on economic development to assist state and local governments to move energy efficiency and other clean energy projects and policies forward with quantitative analysis of economic development impacts.

This project would include literature searches and information gathering, data analysis, computer modeling, information dissemination, conceptual design, paper studies, technical advice and planning assistance.

DOE has determined that this project is consistent with actions covered under DOE CX A9 "Information gathering, analysis, and dissemination" and A11 "Technical advice and assistance to organizations" and therefore is categorically excluded from further NEPA review
