Rationale for determination:

DOE is proposing to publish a Funding Opportunity Announcement (FOA) called Solar Powering America by Recognizing Communities (SPARC), which would establish a prominent national recognition and technical assistance program for local governments that will signal to installers and the public that a community is receptive to solar businesses and has progressive solar policies in place. Through SPARC, DOE would seek to build on recent efforts to help communities move towards more solar-favorable practices and thriving solar markets.

DOE is proposing to make two awards through the SPARC FOA. SPARC awards would not be given directly to local governments; rather, local governments that qualify for recognition will receive a prominent national designation and would join a peer network of leading communities across the country. One of the two awards would support a designation program that would be named and maintained by a Designation Program Administrator (DPA - Topic A). The second award would go to a Technical Assistance Provider that would work with communities that demonstrate a commitment to achieving recognition (TAP - Topic B).

The SPARC FOA would provide funding to establish and administer a designation program and to establish and administer a technical assistance program. Activities funded through the FOA would be limited to administrative activities and technical assistance. These activities are consistent with CX A9 and CX A11. This NEPA determination applies to all awards made under the SPARC FOA.
