Description:

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Los Angeles Cleantech Incubator (LACI) to identify, evaluate and initiate partnerships with technology companies to accelerate deployment of available high impact buildings technologies that meet the performance standards outlined in DOE Technical Specifications or the Technology Demonstration Initiative's (TDI) 20% to 50% energy reduction goals.

The proposed activities would include identification of clean technologies and selection of project sites; implementation of demonstration sites and verification of technology performance; scale up of demonstration sites and establishment of best management practices; and project management and reporting. For demonstrations, installation and monitoring of the various clean technologies would be conducted at existing, privately held, commercial buildings throughout Los Angeles County. The building owner would agree to host a demonstration pilot to test a new building energy efficiency technology. Energy efficient technologies would include, but are not limited to, lighting and lighting controls; high efficiency toilets; irrigation sensors and controls; and window film. There would be five demonstrations installed throughout the duration of the project with each demonstration including one to several buildings at each geographic location. At this time, the specific locations and energy efficiency technologies that would be used in each demonstration are unknown. Installation of demonstration sites and scale ups is prohibited until site location and technology information had been provided to DOE and an additional NEPA review has been completed. This NEPA review is for Budget Period 1 which includes Task 1 and 2 activities only as described in the Statement of Project Objectives (SOPO).

Based on review of the project information and the above analysis, DOE has determined Budget Period 1 activities would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined that Budget Period 1 is consistent with actions outlined in DOE categorical exclusions A9 "Information gathering, analysis, and dissemination", and is therefore categorically excluded from further NEPA review.

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.
