Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Ceramatec, Inc. to develop a modular heat engine power block for applications in distributed Concentrated Solar Power (CSP) technologies.

Proposed project activities would include integration of ion-conducting conversion materials into the heat engine, development of ceramic manufacturing techniques to make low membrane thicknesses, modeling of 3D electrodes to minimize over-potential losses, development of evaporator and condensation components, development of the engine module design, and assembly of a working prototype module. Proposed activities would consist of computer modeling, design and analysis, and indoor, bench-scale laboratory work and would occur at the existing Ceramatec facility in Salt Lake City, Utah.

The facility in which lab work would occur is purpose-built for the type of activities being proposed; therefore, no adverse impacts to sensitive resources are expected as a result of the proposed project. No change in the use, mission or operation of existing facilities would arise out of this effort. The facility has all applicable permits in place, and would not need additional permits for the proposed activities. The project would involve the use of hazardous materials. The materials would be handled in small quantities in a controlled laboratory atmosphere and disposed of in accordance with local, state, and federal regulations.

Based on review of the project information and the above analysis, DOE has determined that the proposed project would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with actions contained in DOE categorical exclusion A9 "information gathering, analysis and dissemination," and B3.6 "small-scale research and development, laboratory operations and pilot projects" and is categorically excluded from further NEPA review.
