Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

Rationale for determination:

The Department of Energy is proposing to provide funding to the state of Indiana to improve energy efficiency at the Wastewater Treatment facility for the town of Brownsburg. The proposed project would replace three 20 horsepower, return-activated sludge pump motors with high efficiency motors, replace existing fluorescent lighting with T5 LED fixtures, and replace illuminated exit signs with LED signs. The motors would be scrapped and recycled. The fluorescent bulbs, fixtures and ballasts would be recycled or disposed of, as allowed by local regulations.

The propose project would not require any ground disturbance or modification to the existing facility.

Based on a review of the project information and the above analysis, DOE has determined that the proposed energy efficiency improvements would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with actions contained in DOE categorical exclusion and B5.1 "Actions to conserve energy or water" and is categorically excluded from further NEPA review.
