Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Certain Solar, Inc. to create a new model for the financing of solar energy projects to account for volatility in net metering laws.

Activities associated with the proposed project would include data collection, analytics, and modeling; collaboration with solar channel partners to develop a new consumer financing contract; and collaboration with potential investors to design a new asset class. Work would be distributed among team members in Washington, DC, Massachusetts, and California. The proposed project would be limited exclusively to intellectual, academic, or analytical activities and would use no physical materials beyond basic office supplies and software.

Based on review of the project information and the above analysis, DOE has determined the proposed project would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined that this project is consistent with actions outlined in DOE categorical exclusions A9 "Information gathering, analysis, and dissemination" and A11 "Technical advice and assistance to organizations" and is therefore categorically excluded from further NEPA review.
