Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development. and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to General Electric Company, GE Global Research (GE) to design, develop, fabricate, and test a polymer-based electrical insulation material.

If successful, the insulation material could enable a 5%-10% electric machine energy savings from implementation of advanced silicon carbide drive systems. GE proposes to eliminate many of the defects from the electrical insulation material, such as voids and de-laminations that lead to partial electrical discharge and decreased efficiency. The proposed project would result in a two-sided, resistive-coating on a polymer film system that will envelop any residual defects which would mitigate the possibility for partial discharge.

Design, development, sample fabrication, and testing will be performed at GE Global Research in Niskayuna, NY. Additionally, material development and fabrication will be completed by vendors.

GE Global Research is a fully permitted industrial research and development site. All work will be performed in conformance with existing permits. Project personnel would receive appropriate training. Safety Risk Assessments and Standard Operating Procedures would be developed, reviewed, and approved prior to work. Risks involve the use of high voltage testing on insulation samples which would be mitigated by conducting testing in electrical cages. The project would also involve the use of solvents and micron-scale filler particles, this work would be conducted in areas with appropriate ventilation.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410 (2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
