Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

B3.15 Small-scale indoor research and using nanoscale materials

Siting, construction, modification, operation, and decommissioning of facilities for indoor small-scale research and development projects and small-scale pilot projects using nanoscale materials in development projects accordance with applicable requirements (such as engineering, worker safety, procedural, and administrative regulations) necessary to ensure the containment of any hazardous materials. Construction and modification activities would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible).

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Florida State University (FSU) for the design, development, and fabrication of superconducting cables for next generation electric machines. Proposed activities would also include the evaluation of various aspects of and obstacles associated with "Conductor on Round Core" cabling and Second-Generation High Temperature Superconductor (2G HTS) conductors.

At FSU in Tallahassee, Florida and at Advanced Conductor Technologies (ACT) in Boulder, Colorado the project would involve the use and handling of cryogenic fluids to allow measurements at cryogenic temperatures. Existing FSU and ACT health and safety policies and procedures would be followed including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

At Super Power, Inc. in Schenectady New York the project would involve the manufacturing of 2G HTS tapes. This would involve the use and handling of various metallic, organic and inorganic raw materials, precursor and processing materials used in the manufacturing process as well as cryogenic fluids. It would also involve the development of nanoscale structures in the 2G HTS film. Existing Super Power health and safety policies and procedures would be followed including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments. Any waste materials would be disposed of in compliance with applicable health and safety regulations.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410 (2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant
