Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Regents of the University of California to develop a new layered control framework termed Phasor-Based Control (PBC) for managing extremely high (> 100%) penetrations of solar generation and other variable energy resources.

The proposed project activities would include theoretical, analytic, and software development work involving algorithm design, modeling and simulations, as well as the interconnection and testing of electrical controller hardware and software. Efforts would be directed towards conducting real-time software-only simulations, real-time testing of the performance of actual physical devices (that include generation, storage and loads) in the control loop, and disseminating simulation results.

Theoretical and software development work would be conducted at the offices of project team members University of California, Berkeley (Berkley, CA), University of Michigan (Ann Arbor, MI), GridBright (Alamo, CA), Lawrence Berkeley National Laboratory (LBNL)(Berkley, CA), and Doosan GridTech (Seattle, WA). Controller hardware-in-the-loop and software testing would be conducted at the offices of Doosan GridTech and at LBNL.

The majority of the project activities would consist of theoretical work, software development, modeling, and installing new software on existing electronic devices. The project would also involve the handling of electrical equipment at typical service voltage levels, e.g. 240V. All of the electrical work activities would be conducted inside existing laboratory work spaces by qualified technical personnel in accordance with all applicable health and safety regulations.

Any work proposed to be conducted at a DOE laboratory may be subject to additional NEPA review by the cognizant DOE NEPA Compliance Officer for the specific DOE laboratory prior to initiating such work. Further, any work conducted at a DOE laboratory must meet the laboratory's health and safety requirements.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410 U.S. DOE: Office of Energy Efficiency and Renewable Energy - Environmental Question... Page 2 of 2

(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
