Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Columbia Power Technologies (CPT) to demonstrate the Columbia Power Wave Energy Converter (CPwr WEC) in a grid connected open ocean

The CPT project is one of three proposed projects that have been selected under the Funding Opportunity Announcement DE-FOA-0001310. Each of the three proposed projects would consist of three budget periods (BP). DOE previously completed a NEPA review for BP 1 of the proposed project (GFO-0007347-001; CX A9; 3/18/2016). DOE is now proposing to fund BP 2 activities. This NEPA determination applies exclusively to BP 2 activities proposed to be undertaken by CPT.

BP 2 activities would include updating the risk analysis, advancement of design, and development of fabrication, transportation, deployment, operations, testing, recovery and decommissioning plans. The proposed BP 2 activities would be limited exclusively to intellectual, academic, or analytical activities to be completed in an office environment and would use no physical materials beyond basic office supplies and software.

Based on the review of the proposal, DOE has determined that activities associated with BP 2 of the proposal fit within the class of action(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. Activities associated with BP 2 of the proposal are categorically excluded from further NEPA review.

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.
