B5.1 Actions to (a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and governments (such as state, local, and tribal). Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Confederated Tribes of the Umatilla Indian Reservation (CTUIR) to implement an energy efficiency measure (LED lighting retrofit) and construct a fixed-rack, ground-mounted solar photovoltaic (PV) array clean energy system to eliminate the net demand for gridbased power for three tribal buildings.

Activities associated with the proposed project would include procurement and installation of LED lighting at the CTUIR Field Station, Public Transit Center Bus Barn and Public Transit Center Maintenance Shop and design,

installation and interconnection of a 96.6 kW solar PV array at the CTUIR Field Station in Pendleton, OR. LED lighting installation would involve wiring and bulb replacement within each fixture and would require two weeks per building to complete the retrofit process. Installation of the PV array would involve installation of concrete footers, the racking system, solar panels and necessary conduit and wiring on previously disturbed land as well as the relocation of pre-existing fencing.

The U.S. Fish and Wildlife Service Endangered Species Program website (IPaC) identifies 3 endangered or threatened species as well as 20 migratory birds that have been known to exist near the project site. However, due to the lack of suitable habitat for these species, nature of the project (solar photovoltaic) and the previously disturbed nature of the site, DOE has determined that there would be no effects to listed species or migratory birds as a result of the proposed project. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

The proposed PV installation presents a risk of electrocution when connecting the solar PV array system to the grid. Utility staff would be present and appropriate personal protective equipment would be worn by all personnel involved. Non-hazardous wastes would consist of the packaging of solar paneling and similar materials. All recyclables would be recycled appropriately and non-recyclables would be disposed of at the landfill.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of 10 CFR 1021 subpart B outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
