Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Long Island Power Authority (LIPA) to analyze and evaluate future generation options, electric transmission systems, and infrastructure requirements to address the New York offshore wind scenarios.

A previous NEPA determination was completed for this (GFO-10-504, A9, 7/16/2010). The original project involved LIPA engaging in the Long Island - New York City Offshore Wind Collaborative (LI-NYC Collaborative). This collaborative is a public-private partnership that came together to study the potential for an offshore wind project that would be situated south of the Queens/Nassau border, On January 10th, 2017 the State of New York announced a commitment to develop up to 2.4 gigawatts of offshore wind power by 2030, to be predominantly located off of Long Island's coastline. This new commitment resulted in changes to the scope of the project and necessitated this NEPA determination.

Revised project efforts would include:

- -Identification of current sources of electric generation, forecasting of peak load, and projection of the amount and types of renewable generation needed to meet NYS mandates.
- -Development of offshore wind power integration project feasibility study and assessment of interconnection cost for the South Fork Wind Project.
- -Identification and evaluation of offshore wind scenarios and identification and evaluation of areas suitable for offshore wind development in the electric service territory.
- -Completion of an independent review of assumptions, planning criteria, and recommendations.
- -Completion of local, regional, state and federal government and inter-agency outreach.
- -Completion of public outreach.
- -Research, analysis, and evaluation of the use of LIDAR for wind resource assessment, monitoring and data.

Activities associated with the proposed project would include data collection, data analysis, report writing, inter-agency coordination, and public outreach. No physical materials beyond basic office supplies and software would be required for the proposed activities.

Based on the review of the proposal, DOE has determined that the proposal fits within the class of action(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not

connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
