Description:

B3.6 Smallscale research and laboratory operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Arizona State University (ASU) to design, develop and fabricate a monolithically integrated solar cell ("M-CELL") and a prototype PV module made of M-CELLs in order to demonstrate performance features allowed by monolithic integration.

The proposed project would consist of laboratory scale research and development in the Solar Power Lab (SPL) at ASU in Tempe, AZ. All design, development, small-scale fabrication, and analytical activities would occur in dedicated laboratory facilities that are purpose-built for semiconductor research. Demonstration of the prototype solar modules would occur indoors using artificial sunlight/shade conditions. The fabrication process being proposed (deposition of amorphous silicon on silicon) has already been performed on-site for related projects; therefore, no modifications or new permits, additional licenses and/or authorizations would be necessary. No change in the use, mission or operation of existing facilities would arise out of this effort.

Proposed activities would involve the use and handling of various hazardous chemicals, including sulfuric and hydrofluoric acids. All such handling would take place in an existing semiconductor clean room following a strict chemical hygiene plan in place for this facility, which incorporates personal protective equipment and safety training for personnel. The proposed project would not present any new materials nor a significant increase in quantities used beyond those encountered in past and ongoing activities at this facility. Hazardous waste generated by the proposed project would be treated on-site in accordance with ASU's chemical waste management plan, and would not require any siting, construction or major expansion of waste storage, disposal, recovery, or treatment actions/facilities. Fabrication and measurements would be performed on equipment that would continue to be used at the Solar Power Laboratory once the project is complete.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
